 - Only 4 companies have expressed to join the tender. However, all of them did not meet our requirement for C39 (Penyenggaraan Sistem Bekalan Air).
 - Hence, zero (0) company able to participate in this Tender.

- 2nd Tender Registration & Site Visit
 - There are 4 companies successfully registered in this Tender and all of them have attend the Site Visit, which are:

- a. Impace Group Sdn Bhd
 - b. Teguh Wibawa Resources
 - c. LME Resources Sdn. Bhd.
 - d. Global HS Consult Sdn. Bhd.
- Tender Purchase
 - Upon closing Tender Purchase of this Open Tender, only two (2) companies purchase this Tender, which are:

 - As per clarification, the other two (2) companies did not purchase this Tender due to:
